Declares to be aware that the State Archives, according to EU regulation 2016/679 (general regulation on data protection), carries out data processing personal data of scholars who request access to the room of study. The treatment, carried out with or without the aid of means electronic, is carried out solely for purposes related to the exercise of discipline that regulates the relationship between the Archive and users. The owner of the processing is the Ministry of Culture, the person responsible for the treatment is the general director "Archives" of the MIC e the person in charge of processing is the director of the State Archives, which benefits from the collaboration of the custodial staff and room. The provision of personal data is mandatory. Refusal involves exclusion from study room services. In relation to the processing of personal data, the interested party has the rights referred to to articles 15 to 22 of the GDPR. These data are processed exclusively for purposes related to the performance of institutional activities of the Institute.
